#### 1. Introduction:

1.1. The National Transport Corporation (NTC) intends to lease out five (5) commercial outlets located at its Riviere du Rempart Regional Office, situated along the Royal Road, in a bid to optimize the commercial use of its ground floor infrastructure and provide business opportunities in a strategic location.

## 2. Details:

2.1. The key features, lease conditions, and responsibilities pertaining to the rental of these commercial premises are outlined below.

# 3. Property Description

#### 3.1. The available units are described as follows:

- Number of Outlets: Five (5)
- Size per Outlet: Approx. 450 square feet each
- Location: Ground Floor, NTC Riviere du Rempart Depot, Royal Road, Riviere du Rempart
- Access: Direct access to the main road
- Parking: Designated parking facilities available
- Utilities Provided:
  - Water supply up to main connection
  - Electricity supply up to main socket point
  - > Sanitary facilities (washrooms) within the premises
- 3.2. These outlets are ideally suited for commercial, retail, or office use.

# 4. Lease Terms

4.1. Initial Lease Duration: Minimum of two (2) years.

- 4.2. Renewal Option: Subject to mutual agreement, lease contracts may be renewed upon satisfactory performance and compliance with lease terms.
- 4.3. Rental Charges: To be determined during negotiation, based on prevailing market conditions and type of commercial activity.

# 5. Tenant's Obligations

- 5.1. The selected tenants shall be responsible for:
  - Installation of individual utility meters, if required
  - Internal maintenance and upkeep of the rented premises
  - Payment of utility bills and rental charges as per agreement
  - Compliance with all applicable laws, health and safety regulations, and NTC policies
  - Limiting usage of the premises strictly to approved commercial activities

# 6. NTC's Responsibilities

- 6.1. NTC shall ensure:
  - Provision of basic utility infrastructure (water/electricity) up to main points
  - General maintenance of external areas and parking facilities

# 7. Site Visit and Expression of Interest

- 7.1. Interested parties are encouraged to conduct a site visit prior to submitting their application. Site visits can be arranged upon request by contacting the STMO of the Riviere Du Rempart Depot on 57964498.
- 7.2. All expressions of interest should be submitted in writing, addressed to the General Manager, along with a brief proposal indicating intended use, company profile, and requested lease duration.
