Bidders will have to abide by the instructions and security arrangements in force at the NTC, during the inspection.

4. The selected bidder(s) will have to remove the scrapped buses from the NTC premises within twenty-five (25) working days after being notified of same in writing. Such removal will have to be effected on weekdays excluding Public Holidays, between 8.00 hrs and 16.00 hrs. No removal of the scrapped buses, will be allowed during week-ends.

- 5. Bidders will have to submit evidence of either possession or lease of equipment for removal of the scrapped buses. However, preference will be given to bidders equipped with cranes or other lifting facilities for carting away of the buses from the premises of the NTC. Possession of such facilities, or any acceptable alternative arrangement, should be clearly mentioned in the Bid Form.
- The National Transport Corporation will not be responsible for any accident or damage to public or private property, once a scrapped vehicle has been removed from its premises.
- 7. Prior to the removal of the scrapped buses from the National Transport Corporation's depot, the selected bidder(s) shall be required to effect payment in advance by Cheque or Bank Transfer in toto for the lots allocated to him.
- 8. A penalty at the rate of Rs 1,000.00 per day per vehicle not removed from the premises of NTC within the prescribed time, will be applied and will have to be paid to the National Transport Corporation prior to the bus being allowed out of the NTC's premises up to a maximum of Rs 10,000/- for each bus. In case the vehicles have not been removed within 45 days, the amount paid to the NTC may be forfeited and the contract may be terminated.

10. Bid Securing Declaration

- 10.1 The Bidder shall be aware of the content of the Bid Securing Declaration and shall subscribe to it by signing the Quotation Submission Sheet at Annex 2.
- 10.2 If a Bid Securing Declaration is not respected, the bidder may be disqualified to be awarded a contract by any Public Body for a period of time as determined by the Procurement Policy Office.

11. The National Transport Corporation reserves the right to (i) split the award (ii) to accept or reject any bid or to cancel the bidding process and reject all bids at any time prior to contract award.

12. Offers in sealed envelopes marked "RFS/NTC/25/39 - Sale of Forty-Four (44) Scrapped Buses", should be lodged in the Tender Box at the Head Office, National Transport Corporation, Bonne Terre, Vacoas not later than Friday 31 October 2025 at 14.00 hours.
