REQUEST FOR EXPRESSION OF INTEREST

for

Bird Control Services at the six (06) depots of the National Transport Corporation

Procurement Reference No: NTC/25/02/EOI

(Authorised under section 24 of the Public Procurement Act 2006)

1. Introduction:

1.1 The National Transport Corporation invites for Expression of Interest (EOI) from eligible and qualified Service Provider/s for the provision of Bird Control Services at the six (06) depots of the National Transport Corporation (NTC).

2. Objective:

2.1 The main objective of this exercise is to pre-select firms which will subsequently be required to submit bids for the provision of skilled, efficient and competent Bird Control Services of the National Transport Corporation – Head Office and 5 Depots.

3. Scope of the Project

3.1 The NTC intends to consider options for the scope of the project - a Bird Control Service provider with all necessary equipment, chemicals and supplies to provide all required services. The service includes but not limited to:

The use of bird control methods, the use of devices (spikes, nest, sound, visual, physical deterrents) to deter birds (pigeon, crows and common birds) from the premises of the NTC – Head Office and Depots.

In this context, as a first step, this Office wishes to appoint Firm/s to effect a detailed survey of the Buildings and their premises for assessing the problems caused by these birds and proposed solutions for controlling them.

The scope of the project is detailed as follows:

- Carry out a complete detailed survey of the buildings and all existing services.
 - The detailed survey of the buildings shall include but not limited to:
 - (i) identify roofs, ledges at various levels, balconies, groundfloor, walls, staircases, openings, shutters and louvers, windows, etc. where birds get access to, leaving droppings that corrode and infest buildings and cause health problems; and
 - (ii) propose methods for removing the existing birds population with animal welfare policies in force.

4. Scope of services

4.1 Terms of Reference for firm (Bird Control Services Provider)

The services to be provided by the Firm/s shall consist of all of the followings as may be necessary in the particular case.

The Firm shall assign the qualified Field Inspector or designated personnel who will be responsible to monitor, coordinate and report regarding the Bird Control Services and personnel involved in the project.

The Firm:

- (a) shall be registered with experience and capacity necessary to undertake the project regarding Bird Control Services;
- (b) will have to work in close collaboration with the Engineering Department, Safety and Health Department and other relevant Authorities for the project;
- (c) shall be responsible for the direction and integration of the work/services of all required staff appointed for the project; and
- (d) shall be responsible for the detailed survey of the buildings concerned, that is :-

- NTC Head Office Vacoas
- NTC Remy Ollier Depot
- NTC La Tour Koenig Depot
- NTC Rivière Du Rempart Depot
- NTC Forest Side Depot
- NTC Souillac Depot

5. Eligibility of Applicant

- a. Firms will be evaluated for the purpose of short listing.
- b. A Firm shall submit only one Expression of Interest.

6. Qualifications of the Firm(s)

The Firm shall have:

- (i) At least **5 years' Experience** in the related field (Birds Control Services) with a highly trained team in performing the tasks; and
- (ii) handled at least two (2) projects of similar size and complexity.

Note: Firms not satisfying the above criteria shall not be shortlisted.

7. Profile of firm/s Bird Control Service providers:

The National Transport Corporation invites Firms to indicate their interest in providing the above-mentioned services.

8. Applicants are required to fill in the annexed Application Forms 1 to 4.

9. Submission of Expression of Interest

The EOI and all documents in a sealed envelope clearly marked: "EOI for Bird Control shall be deposited in the Tender Box "A" located in the photocopy area at the Head Office of the NTC, Bonne Terre, Vacoas, by **12 December 2025** up to 14.00 hours (local time).

Late submission shall not be considered.

Proposals will be opened in the presence of the Firm's representatives who choose to attend at the address given above.
